 - Josh Shapiro* (D) defeated Heather Heidelbaugh (R)
- Utah
 - Sean D. Reyes* (R) defeated Greg Skordas (D)
- Vermont
 - T.J. Donovan* (D) defeated H Brooke Paige (R)
- Washington
 - Bob Ferguson* (D) defeated Matt Larkin (R)

- Nonpartisan Efforts
 - Consumer Protection
 - False Claims
 - Human trafficking
- Partisan Efforts
 - Democratic State Attorneys General
 - No longer have the Trump Administration to focus on.
 - Democratic State Attorneys General sued Trump Administration 138 times.
 - Environmental
 - Immigration
 - Labor
 - Teaming with Biden Administration in certain regulatory areas
 - Environmental enforcement actions
 - Labor/Worker Misclassification
 - Big Tech
 - Republican State Attorneys General
 - Challenging Executive Actions
 - Defending against regulatory overreach by Biden/Harris administration
 - Areas of interest will include: energy and climate change, health care, financial services, communications policy, 2nd Amendment.

How to Be Prepared

- Engagement
 - State Attorneys General are very active and that will continue
 - Regular Monitoring is important
 - Engaging with regulatory offices early in the process can be helpful
- Compliance
 - Ensuring that compliance programs are up to date and reflect the most recent areas of State Enforcement
- Litigation/Investigations
 - Working with State Attorneys General is often different that other regulators and should be treated as such
