**AFFIDAVIT OF
JOSIAS N. DEWEY**

I, Josias N. Dewey, being duly sworn, deposes and says under penalty of perjury:

1. I am an attorney with the law firm of Holland & Knight LLP, admitted to the practice of law in Florida, Bar Number 143870. I am over 18 years of age, of sound mind, and otherwise competent to make this Affidavit. The evidence set out in the foregoing Affidavit is based upon my personal knowledge.

2. I submit this Affidavit in support of the June 7, 2022 Attorney Affirmation of Service filed by Elliot A. Magruder [NYSCEF No. 17].

3. I am a Solidity programmer, the computer language used for smart contracts published on the Ethereum blockchain.

4. I created the Service Token pursuant to the Court's June 2, 2022 Order to Show Cause and Temporary Restraining Order [NYSCEF No. 15]. Specifically, I created a smart

contract to mint an ERC-721 non-fungible token (the Service Token) and published the smart contract on the Ethereum blockchain at address 0xdc9ec0C966c3d3A552A228b3fe353848CE2F25f4.

5. The Service Token includes, in the name of the Token itself, the Service Hyperlink: <https://2no.co/LCXAGService>.

6. On June 6, 2022, I minted the Service Token and airdropped it to Ethereum blockchain address 0x29875bd49350ac3f2ca5ceeb1c1701708c795ff3—the Address.

7. Anyone with access to a blockchain explorer like Etherscan can verify the existence of the Service Token, that the Service Hyperlink is included in the Token’s name, and that the Token was delivered to the Address on June 6, 2022. For example, attached hereto as Exhibit 1 is a true and correct June 24, 2022 copy of the Etherscan web page displaying the Service Token at <https://etherscan.io/nft/0xdc9ec0c966c3d3a552a228b3fe353848ce2f25f4/1>.

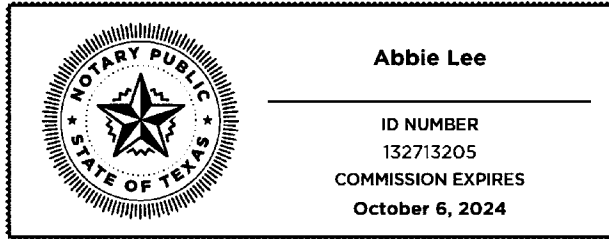
