4. Internet Protocol (IP) logging services track when a hyperlink is clicked on, among other things.

- 5. Link shorteners provide proxy universal resource locators (URLs) to websites forwarding users from the shortened URL to the intended destination website—and are often used to shorten links, thus the name.
- I used an IP logging link shortener provided by IP Logger (located at 6. https://iplogger.org/) to shorten the Service Webpage hyperlink to https://2no.co/LCXAGService (the "Service Hyperlink").
- 7. On June 3, 2022, I visited the Service Hyperlink and verified that it directed me to the Service Webpage.
- 8. I then emailed the Service Hyperlink to Mr. Josias N. Dewey for use in the Service Token.
- 9. I reviewed the IP Logger tracking statistics for the Service Hyperlink. As of 3:46 PM on June 15, 2022, the Service Hyperlink had been clicked on by 256 unique non-bot visitors. Bots are programs—in this context, programs which crawl the web and click on links to gather information for their owners. I excluded bots and internal test "clicks" from the Service Hyperlink visitor count. Attached hereto as Exhibit 1 is a true and correct list of the dates and times of the Service Hyperlink visitors as of 3:46 PM on June 15, 2022. IP Logger's terms of use prohibit me from publishing private information about specific visitors.
