Theft of cryptocurrency; against unknowns

Dear,

On behalf of LCX AG, Herrengasse 6, 9490 Vaduz, we raise

LEGAL PROCEEDINGS AGAINST UNKNOWN.

LCX AG is the operator of the Internet platform LCX.com, which among other things enables trading in crypto currencies on LCX Exchange (exchange.LCX.com). LCX AG is registered as a TT service provider according to TVTG. LCX follows strict security requirements and has an internal policy called "Information Security, Blockchain Operations and Business Continuity Policy".

Facts: Theft of crypto currency

At the current status of our internal analysis, a hacker gained access to the most important wallet on the LCX platform. The affected is the LCX hot wallet on the Ethereum blockchain with the wallet address 0x4631018f63d5e31680fb53c11c9e1b11f1503e6f.


Due to the high security measures, access to LCX wallets is excluded. How the hacker gained access is unclear.

The LCX hot wallet can be viewed online on Ethereum Explorer, the hack is traceable and you can see how the cryptocurrencies are forwarded by the hacker. See https://etherscan.io/address/0x4631018f63d5e31680fb53c11c9e1b11f1503e6f

The theft takes place yesterday evening, January 8, 2022 between 23:23 and 23:37 instead.

- On January 9th at 01:52 a.m. we informed our partner Monerium about the hack. Monerium is the publisher of the Digital Euro (EURe) on Ethereum Blockchain, which is used on the LCX platform. In total, the hacker was able to gain access to EUR 761,236.94. The hacker was able to switch EUR 150,236.94 in DAI to Uniswap DEX. At 05:56, LCX was informed by the Monerium team that the Monerium team had managed to block and freeze EUR 611,000 at 04:44.
- On January 9th at 02:04 a.m. we informed our partner Liquid Global (liquid.com). The hacker wallet has been blacklisted so that hackers can no longer make deposits.

- On January 9th at 3:13 a.m. we informed our partner Elliptic about the hack. Elliptic is LCX's
 partner for Blockchain Transaction Monitoring and Blockchain Analytics. Elliptic marks the Hacker
 Wallet for all Elliptic customers and warns other platforms.
- On January 9, 2022 from around 5:00 a.m., we transferred cryptocurrencies from the other LCX
 wallets to new wallets. With this we try to prevent further theft. At the current status, no other LCX
 wallets are affected by the theft.
- On January 9, 2022 at around 12:30 p.m., LCX reports to the Liechtenstein police.
