
**DECLARATION OF PLAINTIFF JONATHAN ZARLEY**

I, JONATHAN ZARLEY, declare under penalty of perjury as follows:

1. I am a named Plaintiff in the above-captioned proceeding.
2. I am a citizen and resident of Kamuela, Hawaii.
3. I am over the age of 18, am personally familiar with, and have personal knowledge of the facts contained herein, which I could and would testify competently thereto.
4. I registered for a RoFx.net account on or about January 27, 2020.
5. Between January 2020 and May 2021, I invested a total of \$2,067,000 with RoFx.net. Specifically, I sent a total of 28 wire transfers to Aware Choice Ltd, Notus LLC, Global E-Advantages LLC, and Shopostar LLC.
6. During that same time period, RoFx.net allowed me to withdraw \$288,000 from my RoFx.net account.
7. All of my RoFx.net withdrawals were wired to me by Boonruk Ruamkit Co., Ltd. Pursuant to Section 1746 of Title 28 of the United States Code, I declare under penalty of perjury that the foregoing is true and correct.
