Plaintiffs' Amended Complaint originally brought claims against <u>forty-two</u> named Defendants. *See* ECF No. 64. The status for each Defendant is summarized as follows:

- <u>Twenty-six</u> Defendants have had Clerk's defaults entered against them and are the subject of Plaintiffs' pending Motion for Default Judgment;
- <u>Five</u> Defendants cannot be served with process because Plaintiffs have been unable to confirm they are unaffected by the Ukraine war and/or locate reliable contact information;
- <u>Two</u> Defendants have not been served because Plaintiffs have been unable to identify reliable contact information;
- Three Defendants are in settlement discussions with the Plaintiffs; and
- <u>Six</u> Defendants have been dismissed.
