CFPB Consent Order with Hanna & Associates

- CFPB alleged that Hanna was operating an illegal debt collection lawsuit mill
- Terms of Consent Order:
 - End "intimidating" collection tactics;
 - Increase attorney involvement before suit filed against consumers;
 - Cease the use of "deceptive" court filings; and
 - Pay a \$3.1 million dollar penalty.

FTC Letter to CFPB on Debt Collection Efforts

- Reported on FTC's actions with respect to:
 - Coordination between the FTC and CFPB;
 - Joint law enforcement initiative between the FTC and state attorneys general;
 - Recent law enforcement actions involving the FTC and states jointly;
 - Activities by state attorneys general by themselves;
 - FTC and CFPB conduct first joint law enforcement action;
 - Areas of concern; and
 - CFPB and FTC jointly filing amicus briefs

Recent CFPB Actions: Citibank

- Dual enforcement action
 - addressed debt sale practices and debt collection efforts.
- Citibank required to:
 - adjust debt sale practices; and
 - cease use of falsified court documents in debt collection cases.
- CFPB continuing focus on debt collection industry, and use of lawsuits to collect on debts.

Recent CFPB Actions: Supervisory Highlights

- Quarterly CFPB Report for Supervision, Winter 2016
- Main issue identified through supervision:
 - ensuring information reported to consumer reporting agencies is accurate, including the debt collection industry.
