The financial impact caused by the COVID-19 pandemic has left many businesses with little choice but to lay off significant numbers of employees. Financial institutions that had previously extended credit to impacted businesses are often faced with a need to exercise one or more remedies as the related credit defaults put at risk their ability to collect

The U.S. Department of Justice (DOJ) has taken an aggressive stance against those seeking to exploit the COVID-19 crisis through fraudulent and otherwise illegal schemes, and is emphasizing several tools currently available to federal prosecutors to deal decisively with the alleged criminal schemes. Recent DOJ enforcement actions highlight the government's efforts to use this robust prosecutorial tool to combat coronavirus-related fraud. In addition to making sure that the applications for and/or certifications regarding use of COVID-19 relief funds are accurate and appropriate, special attention should be paid to making sure that the use of "means of identification" is scrupulously accurate.

The Cyberspace Solarium Commission (CSC) issued a report entitled, "A Warning for Tomorrow," making more than 80 recommendations to Congress for new policies to protect tribal, local, state and federal governments as well as the private sector and private citizens from cyberattacks. The CSC has updated its report with a pandemic annex (Pannex) to reflect vulnerabilities further exposed by COVID-19. The Pannex includes a request for Congress to establish a grant program to modernize digital infrastructure in the next COVID-19 relief package.
