Before the pandemic, telehealth coverage was limited in scope. The Centers for Medicare & Medicaid Services (CMS) recently expanded coverage through its regulatory authority and waivers to encourage broad adoption of telehealth for the duration of the public health emergency. Over the last few months, we have seen an exponential increase in telehealth. Before the public health emergency, according to

CMS, approximately 13,000 beneficiaries in fee-for-service (FFS) Medicare received telemedicine in a week. In the last week of April, nearly 1.7 million beneficiaries received telehealth services. Moving forward, CMS can make a number of these changes permanent through rulemaking.
