General	Allowing for certain non-critical sector workers to return to work once employers have provided a safe work environment.		
Shelter in Place - Modified	Effective 4/26/20 at 11:59 pm, stay at home provisions are modified, so that workers for Non-Critical Exempt Businesses may return to work upon employers' completion of the requirements set forth in this order. Applies only to work duties that cannot be performed at residence. All workers who can work from home must do so.	1, 2	
Requirements for Non-Critical Exempt Businesses	 Requirements include establishment and implementation of a COVID-19 Preparedness Plan. Elements include: implementation of OSHA, MDH and CDC guidelines, requirements for work from home where possible, policies and procedures (including health screenings) that prevent sick workers from entering workplace social distancing, hygiene, source control, and cleaning and disinfectant protocols A template is provided at https://mn.gov/deed/safework/. Order contains other provisions for certification, posting, training, compliance, and availability of plan to regulatory authorities. Plans do not need to be submitted for preapproval. 	6, 7	
Impact on other orders	Except for the additional exemptions provided by this order, Executive Order 20-33 remains in effect.
