Employers should: Encourage good hygiene and sanitation practices, especially in high-traffic areas Encourage employees to stay home when sick If previously operating via telework, begin transitioning employees back to the workplace Where appropriate, screen employees for symptoms prior to entering the workplace Resume operations in a manner that allows for reasonable physical distancing, good hygiene, and appropriate sanitation Consider restricting occupancy and continue innovating in this uncertain environment

Public/Entertainment Venues	Never ordered closed, but should consider CDC guidelines and adhere to local restrictions.	
Restaurants, Bars	Never ordered closed, but should consider CDC guidelines and adhere to local restrictions.	
Permitting Elective Surgeries, Etc.	Non-hospital healthcare, including clinic visits, can resume so long as providers secure adequate supplies of personal protective equipment without relying on the state supply.	
Facemask Requirements	Masks have never been required, but South Dakotans are encouraged to continue to consider CDC guidance and use.	
Gatherings	Never restricted, but people are encouraged to continue practicing social distancing, as appropriate.	
Other	Churches are encouraged to consider the guidelines for "public gatherings" and to consider steps to maintain reasonable physical distancing.
