General	Utah adopted the Utah Leads Together Plan, version 2.0 (“Reopening Plan”), and Phased Guidelines, to reopen businesses in phases, by county. Various executive orders, starting with EO 19 on 5/1/20, moving different counties from Red, to Orange, to Yellow, to Green phases. See Health Guidance System for the current status of particular counties.	EO 19, 20, Phased Guidelines 4.7
Directives for Individuals; Shelter in Place rescinded	Prior “Stay Safe, Stay Home” directive was rescinded. Individuals to comply with Phased Guidelines. Different guidelines for general public and for high-risk individuals. Guidelines include detailed provisions re social distancing, face coverings, hygiene, gatherings, children (including playgrounds), outdoor activities (including sports and pools), and worship services.	See Phased Guidelines 4.7
Directives for Businesses	Prior “Stay Safe, Stay Home” directive is rescinded. All businesses and employees to comply with Phased Guidelines. Guidelines include detailed requirements for enabling work from home, face coverings, provisions for dine-in and take-out restaurants, signage, disinfection, distancing, protective measures, provisions for hotels, events and entertainment venue provisions, personal services provisions (barbers, hair salons, etc), home repair provisions, construction provisions, day care, health care, etc.	Phased Guidelines 4.7
Essential/Nonessential Businesses	No distinction between essential and non-essential businesses.	
Travel	See travel provisions in Phased Guidelines.	Phased Guidelines 4.7
Face coverings	Effective 6/29/20, face coverings are mandatory in state facilities, with certain limited exceptions. Face coverings are mandatory for	EO 33
