1. I am a partner with the law firm of Thompson & Knight LLP ("**T&K**") in Dallas, Texas. I am a member in good standing of the bar of the State of Texas, and am admitted to practice in the United States District Courts for all Districts of Texas. There are no disciplinary proceedings pending against me.

- I am the Court-appointed Receiver (the "Receiver") for the Thurman P. Bryant, III ("Bryant") and Bryant United Capital Funding, Inc. ("BUCF") (Bryant and BUCF, collectively, the "Bryant Defendants") and Relief Defendant Arthur F. Wammel ("Wammel"), Relief Defendant Wammel Group, LLC (the "Wammel Group"), and Wammel Group Holdings Partnership ("WGHP") (together Wammel, Wammel Group, and WGHP, the "Wammel Defendants") receivership estates (together, the "Receivership Estate" or the "Receivership") in this case. I am fully familiar with the facts and procedural history of this case and the information contained in this Declaration is within my personal knowledge.
- 3. I submit this Declaration in support of the Motion of Receiver (I) for Order Authorizing Liquidation of Furniture, Fixtures, Equipment, and Other Items and Termination of Certain Leases, (II) to Approve Procedures to Sell Certain Personal Property, and (III) to Release Funds from Certain Frozen Bank Accounts into the Receiver's Account.
- 4. Since my appointment, my team and I have worked diligently to begin the process of collecting, marshaling, and taking control over the Receivership Property pursuant to this Court's directives.
- 5. As part of that work, my team and I took control and possession of certain personal property owned by the Bryant Defendants, and identified in **Exhibit A** attached hereto.
- 6. I discovered that the Bryant Defendants Receivership Estate was bound by lease agreements related to the Home, a virtual office in Katy, Texas, Public Storage units (containing the Storage Property), three Cadillac vehicles leased with GM Financial, and a horse barn where the Defendants board a horse. These leases give rise to recurring monthly expenses: (1) the monthly rental expenses for the Home of approximately \$19,000 per month, (2) the monthly rental charge for two storage units held in Defendant Bryant's name of approximately \$498.40

per month, (3) the monthly leasing cost of three Cadillac vehicles of approximately \$3,421.47,

and (4) the monthly stable expense for a horse.

leases and the current outstanding liabilities of the Receivership, I believe it is necessary to

terminate these unnecessary leases in order to immediately reduce Receivership expenses.

8. All facts set forth in this Declaration are based on my personal knowledge and my

involvement as Receiver in the above-captioned case.

- 2. I am an accountant hired to assist Jennifer Ecklund, the Court-appointed Receiver (the "Receiver") for Thurman P. Bryant, III and Bryant United Capital Funding, Inc. (collectively, the "Defendants") receivership estates (together, the "Estate") in this case.
- 3. I submit this Declaration in support of the Motion of Receiver (I) for Order Authorizing Liquidation of Furniture, Fixtures, Equipment, and Other Items and Termination of Certain Leases, (II) to Approve Procedures to Sell Certain Personal Property, and (III) to Release Funds from Certain Frozen Bank Accounts into the Receiver's Account.
- 4. As part of my work, my team and I have found that investor funds were, in most instances, deposited into the Bryant United Capital Funding accounts and then disbursed as directed by Defendant Thurman P. Bryant, III. The investor funds deposited into the Bryant United Capital Funding accounts were often transferred to different accounts, including the Wammel Group, ProLiquidation, and Mr. Top Agent Entertainment. The investor funds were also transferred and used for the apparent purpose of home renovations or upkeep and general living expenses.
- 5. My team and I confirmed that investor funds from Thurman P. Bryant, Jr. and Roland J. Maldonado were deposited into accounts held by Bryant United Holdings, Inc. on April 11, 2011 and July 11, 2011, respectively. Starting in July 2011, investor funds were deposited into accounts controlled by Bryant United Capital Funding and Thurman P. Bryant III. None of the accounts, from 2011 to 2017, were secure escrow accounts. The last significant transfer of funds from the Bryant United Holdings account occurred on July 11, 2011 in an amount of \$211,500 to the Wammel Group. 


