RELIEF DEFENDANTS ARTHUR F. WAMMEL AND WAMMEL GROUP. LLC'S ORIGINAL ANSWER TO PLAINTIFF'S COMPLAINT

Relief Defendants Arthur F. Wammel and Wammel Group, LLC (collectively "Relief Defendants") file this Original Answer to Plaintiff's Complaint ("Complaint").

ANSWER

- 1. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 1 of the Complaint.
- 2. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 2 of the Complaint.

- 3. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of all of the allegations contained in Paragraph 3 of the Complaint. Relief Defendants deny that Bryant funneled approximately \$16.1 million to Wammel and Wammel Group. Relief Defendants, however, admit that Bryant invested funds with Wammel Group.
- 4. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 4 of the Complaint.
- 5. Relief Defendants lack sufficient knowledge or information to form a belief as to the truth of whether BUCF's investors were told of Wammel Group's involvement or use of their funds. Relief Defendants admit that since 2011 Bryant invested funds with Wammel Group. Relief Defendants deny the remaining allegations contained in Paragraph 5 of the Complaint.
- 6. Relief Defendants admit that Wammel Group has paid substantial sums to BUCF. Relief Defendants further admit that in April 2017 Wammel removed approximately \$385,000 from options trading accounts under his control and in which BUCF investor funds were received. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations that Defendants never disclosed to investors that their funds would be transferred to Wammel and Wammel Group. Relief Defendants lack sufficient knowledge or information to form a belief as to the truth of the allegations that BUCF investors were promised 30% returns. Relief Defendants deny the remaining allegations contained in Paragraph 6 of the Complaint.
- 7. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 7 of the Complaint.
- 8. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 8 of the Complaint.

- 9. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 9 of the Complaint.
- 10. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 10 of the Complaint.

- 13. Relief Defendants admit that Wammel Group is a Texas limited liability company with its principal place of business in Kemah, Texas, and that Wammel Group received funds from BUCF. Relief Defendants deny the remaining allegations contained in Paragraph 13 of the Complaint.
- 14. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 14 of the Complaint.
- 15. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 15 of the Complaint.
 - 16. Paragraph 16 contains only legal conclusions for which no response is required.
 - 17. Paragraph 17 contains only legal conclusions for which no response is required.
- 18. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 18 of the Complaint.
- 19. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations in contained in Paragraph 19 of the Complaint.

- 35. Relief Defendants admit that the investment revenues were less than the sums it distributed to BUCF. Relief Defendants deny the allegations contained in Paragraph 35 of the Complaint.
- 36. Relief Defendants admit the allegations contained in Paragraph 36 of the Complaint.
- 37. Relief Defendants admit the allegations contained in Paragraph 37 of the Complaint but deny that Wammel Group accounts contained ill-gotten gains obtained from investors.
- 38. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 38 of the Complaint.
- 39. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 39 of the Complaint.

- 40. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 40 of the Complaint.
- 41. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 41 of the Complaint.

information to form a belief about the truth of the allegations that Wammel Group's options trading and other investments deviate from BUCF's purported short-term mortgage lending business. Relief Defendants deny the remaining allegations contained in Paragraph 49 of the Complaint.

- 50. Relief Defendants lack sufficient knowledge or information to form a belief as to the truth of the allegations that BUCF investors were promised 30% returns. Relief Defendants deny the remaining allegations contained in Paragraph 50 of the Complaint.
- 51. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 51 of the Complaint.
- 52. Relief Defendants lack sufficient knowledge or information to form a belief about the truth of the allegations contained in Paragraph 52 of the Complaint.
